## Invitation to Bid for

### *DRILLING OF EXPLORATORY/PRODUCTION WELLS for Manapla Water District*

*(Provision of Water Supply to NHA Permanent Resettlement Sites Housing  
Program in Yolanda Affected Areas)*

1. The **MANAPLA WATER DISTRICT (MWD)**, through the RA No. 10633 (FY 2014 GAA) and R.A. No. 10717 (FY 2017 GAA) to finance the water supply needs of NHA Permanent Resettlement Areas in Yolanda Affected Water Districts and Municipalities from the Government of the Republic of the Philippines intends to apply the sum of **₱5,209,640.00** being the Approved Budget for the Contract (ABC) to payments under the contract for **DRILLING OF EXPLORATORY/PRODUCTION WELLS FOR MANAPLA WATER DISTRICT**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

All infrastructure projects are packaged in lots listed below. Bidders shall have the option of submitting a proposal on any or all lots and evaluation and contract award will be undertaken on a per lot basis. Lots shall not be divided further into sub-lots for the purpose of bidding, evaluation, and contract award.

2. The MWD, through its Bid and Awards Committee (BAC), now invites bids for Drilling of Exploratory/Production Wells for Manapla Water District as specified herein. Completion of the Works is required within **One Hundred Eighty (180) calendar days for Lot No. 1 and Ninety (90) calendar days for Lot 2** after receipt of Notice to Proceed. Bidders should have completed, within five (5) years prior to the date of submission and receipt of bids, a single largest completed contract (SLCC) similar to the Project, equivalent to at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the BAC Secretariat, Manapla Water District Office, Manapla, Negros Occidental and inspect the Bidding Documents at the address given below from 9:00 A.M. – 4:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting **July 9, 2020** from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos Only (Php 5,000.00) per lot.**
6. The MWD will hold a Pre-Bid Conference on **July 17, 2020 at 2:00 P.M.** at Don Edilberto B. Vocal Sr. Memorial Civic Center, B. Gallo St., Brgy. I-B, Manapla, Negros Occidental, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at Don Edilberto B. Vocal Sr. Memorial Civic Center, B. Gallo St., Brgy. I-B, Manapla, Negros Occidental on or before **2:00 P.M. on July 29, 2020.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**

8. The MWD reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
